Statement of benefits under the Act of March 2, 2020 on special solutions related to the prevention, prevention and control of COVID-19, other infectious diseases and crisis situations caused by them (Journal of Laws, item 374, as amended) and Regulations No. 419/20 of the Mayor of the City of Gdansk of April 1, 2020 regarding determination of specific forms of assistance to the local community related to prevention, counteracting and combating COVID-19 in the Municipality of Gdansk.

---

- 1 Earmarked allowance** intended for the purchase of medicines, cleaning products and cleaning products hygienic (application to emergency centre MOPR).
- 2 Provision and delivery of a meal or food products** (application to emergency centre MOPR).
- 3 Purchase and supply of medicines and other items necessary for survival first need** (application to emergency centre MOPR).
- 4 Providing shelter** (application to emergency centre MOPR).
- 5 Material assistance in the form of clothing and household goods** (application to emergency centre MOPR).
- 6 Crisis intervention and specialized psychological counseling** (application to emergency centre MOPR / emergency response centre OIK).
- 7 Additional care allowance for up to 14 days per child under 8 years old in case of closing kindergarten / school** (application to Social Insurance Institution ZUS).
- 8 Additional care allowance for a period not exceeding 14 days for a child with a significant or moderate disability up to the age of 18 or a child with a certificate on disability or a decision on the need for special education** (application to Social Insurance Institution ZUS).
- 9 Sickness benefit due to an insured practitioner employed in a medical entity during the period of compulsory compliance quarantine or isolation at home** (application to Social Insurance Institution ZUS).
- 10 So-called "Parking benefit"** (application to Social Insurance Institution ZUS).
- 11 Co-financing of salaries of employees, employees based on outwork contract or mandate contract or other service contract** (application to Gdansk Job Centre GUP).

**12 Co-financing the costs of doing business by self-employed people** (application to Gdansk Job Centre GUP).

**13 A loan from the Labor Fund to cover current running costs business activity of a micro entrepreneur** (application to Gdansk Job Centre GUP).

**14 Co-financing of remuneration of persons employed by non-governmental organizations and other entities conducting public benefit activities** (application to Gdansk Job Centre GUP).

**15 Compensation of costs incurred by professional activity plants remuneration paid to people with disabilities** (application to The State Fund for Rehabilitation of Disabled People PFRON).
